BY LAW NUMBER 2023-007: REVISED WASTE MANAGEMENT & COMPOSTING BY-LAW

<u>REPLACING BY LAW NUMBER 2023-002: WASTE MANAGEMENT &</u> <u>COMPOSTING BY-LAW</u>

- **WHEREAS** By Law 2023-002 was presented at the **January 16, 2023**, Council meeting and a motion of notice was given by Councillor: Darryl Mayer
- **WHEREAS** By Law 2023-007 was presented at the **July 10, 2023**, Council meeting and a motion of notice was given by Councillor: James Giroux.
- **WHEREAS** the Municipal Council of Alleyn and Cawood want to offer an improved waste management system to their ratepayers;
- **WHEREAS** the Municipal Council of Alleyn and Cawood will introduce a new policy of waste removal and now offer a composting service;
- **WHEREAS** the Municipal Council of Alleyn & Cawood would like to encourage recycling and composting in order to receive financial benefits, such as grants from the provincial government, the municipality will pay less money per ton for recycling and composting as opposed to household garbage;
- **WHEREAS** the Municipality has purchased a standard size garbage truck and will provide bins for household waste (garbage), recycling and composting that will be distributed to all residents with a building or trailer on their property.
- **ARTICLE ONE:** the Municipality will distribute garbage, recycling and composting bins to each property with a building or trailer. Each residential property will receive two of each bin if required. Each property will be able to purchase additional bins at a cost of \$165 for garbage bin, \$100 for recycling bin and \$80 for a composting bin. If in the event a bin is destroyed, damaged or stolen, it is the responsibility of the ratepayer to replace the bin. You cannot provide your own bin; it has to be a bin provided by the Municipality.
 - 1.1 If you request an additional garbage bin you will have to purchase a bin at the cost of \$165 and you will have an additional yearly charge on your tax bill of \$300 for the added garbage that the municipality will be collecting. The purpose of this By-Law is to encourage ratepayers to recycle and compost more.
 - 1.2 The composting service will be available in 2024 and compost bins will be delivered to each ratepayer.
- **ARTICLE TWO:** The Municipality will no longer pickup garbage bags that are not inside the household waste bins. All bags (both household waste & recycling) must be inside the appropriate container to ensure that no bags are torn open by animals or birds.
- **ARTICLE THREE:** The new truck will not be able to operate on private roads, due to a number of restrictions: road width, winter plowing, etc. As a result, the

municipality will have to set up places where residents with properties on private roads can bring their bins, so that the municipality can collect from them. The municipality will be responsible for landscaping the site (clearing brush where necessary and placing materials such as sand or rock to level the access) however the municipality will not be in charge of its summer or winter maintenance.

- **ARTICLE FOUR:** It is the responsibility of the ratepayer to identify their bins. The ratepayer can, for example, write their address on the bins with paint or lettering.
- **ARTICLE FIVE**: If the ratepayer had an existing curbside bin for their household waste and recycling, they must remove it as soon as the new procedure is in operation as indicated on the 2023 Collection Calendar.
- **ARTICLE SIX:** The Municipality will publish annually a Collection Calendar indicating when each pickup will be scheduled. Garbage and recycling pickups will by weekly. Composting will be picked up weekly for the months of May to October then they will switch to a by-weekly pickup for the months of November to April.
- **ARTICLE SEVEN:** The bins serial number are attached to each property. If you are selling you property, the bins must remain on the property and passed on to the next property owner.
